**Budget Trailer Bill RN 15 02736 (1/22/15)**

Dear Assembly Member Bloom:

On behalf of the thirty-four member counties of the Rural County Representatives of California (RCRC), I appreciate the opportunity to comment once again on the Governor's 2015-16 proposed State Budget appropriation for the Payment In-Lieu of Taxes (PILT) and related proposed budget trailer bill language. As you recall, the issue was heard in Assembly Budget Subcommittee #3 on March 4<sup>th</sup> and after hearing testimony, the item was left open.

# Senate Budget and Fiscal Review Subcommittee #2

Following the Assembly Budget Subcommittee #3 hearing, the issue of PILT was heard in the Senate Budget and Fiscal Review Subcommittee #2 on April 9. The Senate Budget Subcommittee:

- Approved the budget item as proposed (\$644,000 General Fund);
- Approved the trailer bill language as provisional <u>striking language making payments</u> permissive; and,
- Added an \$8 million General Fund appropriation for payment of the PILT arrears owed to 36 counties.

#### Administration PILT Calculations

As you may recall, the Department and Fish and Wildlife's (DFW) 2014/2015 Unpaid In-Lieu Fees chart (dated May 16, 2014) estimated the past due amount of PILT payments owed to 36 counties to be \$18,682,283, and the annual PILT payment owed to these counties was estimated to be \$1,551,810. The DFW chart is attached.

In its proposed 2015-16 State Budget, the Administration has proposed to back-out the amount owed to counties based on a specified percentage identified as the property tax allocation for school districts. The remainder – in a total amount of \$643,817 - would be remitted to the 36 PILT counties. The Legislative Analyst's Office (LAO), utilizing the DOF school district percentage calculations, has estimated the PILT arrears (as of May 16, 2014) to be \$7,784,426.

# Proposed Budget Trailer Bill

The Administration has proposed Budget trailer bill language that would make PILT payments permissive by changing "shall" to "may". RCRC must continue to oppose this change to existing law. A copy of the Administration's proposed Budget trailer bill, RN 15 02736, is attached.

In conclusion, RCRC respectfully urges the Assembly Budget Subcommittee #3 to:

- Approve the Administration's proposed PILT appropriation of \$643,817 for Fiscal Year 2015-2016;
- Add an appropriation of \$8 million General Fund for payment of the arrears; and,
- Reject the Administration's proposed changes to Fish and Game Code 1504 (a), (c), (e), and (f).

# LEGISLATIVE COUNSEL'S DIGEST

General Subject: Fish and game: wildlife management areas: payment of taxes and assessments.

Existing law regulates the acquisition of real property acquired and operated by the state as wildlife management areas, and requires the Department of Fish and Wildlife, when income is directly derived from real property acquired and operated by the state as a wildlife management area, as provided, to annually pay to the county in which the property is located an amount equal to the county taxes levied upon the property at the time the property was transferred to the state. Existing law further requires the department to pay the assessments levied upon the property by any irrigation, drainage, or reclamation district, and requires all of those payments to be from funds available to the department.

This bill would, instead, authorize the department to pay those amounts for taxes and assessments on the property, and would require that those payments only be made

An act to amend Section 1504 of the Fish and Game Code, relating to fish and wildlife.

# THE PEOPLE OF THE STATE OF CALIFORNIA DO ENACT AS FOLLOWS:

SECTION 1. Section 1504 of the Fish and Game Code is amended to read:

- operated by the state as a wildlife management areas, area, and regardless of whether income is derived from property acquired after October 1, 1949, the department shall may pay annually to the county in which the property is located an amount equal to the county taxes levied upon the property at the time title to the property was transferred to the state. The department shall may also pay the assessments levied upon the property by any irrigation, drainage, or reclamation district.
- (b) Any delinquent penalties or interest applicable to any-such of those assessments made prior to before September 9, 1953, are hereby canceled and shall be waived.
- (c) Payments provided by this section shall <u>only</u> be <u>made</u> from funds <del>available</del> that are appropriated to the department for the purposes of this section.
- (d) As used in this section, the term "wildlife management area" includes waterfowl management areas, deer ranges, upland game bird management areas, and public shooting grounds.
- (e) Payments Any payments made under this section shall be made on or before December 10 of each year, excepting with the exception of newly acquired property for which payments shall be made pursuant to subdivision (f).
- (f) Payments Any payments made for the purposes of this section shall be made within one year of the date title to the property was transferred to the state, or within 90 days from the date of designation as a wildlife management area, whichever occurs



first, prorated for the balance of the year from the date of designation as a wildlife management area to the 30th day of June following the date of designation as a wildlife management area, and, thereafter, payments shall be made on or before December 10 of each year.

(g) Notwithstanding any other law, payments provided under this section shall not be allocated to a school district, a community college district, or a county superintendent of schools.
